



Arkansas Department of Parks, Heritage and Tourism (ADPHT) Contest Rules

1. THE CONTEST. Arkansas Tourism (a division of ADPHT) is celebrating America 250 at the Great American State Fair with a giveaway!

One lucky winner will receive a three-night trip for two to Arkansas, including round-trip flights and lodging, and a \$500 Visa gift card – all valued at \$3,500.

2. THE ENTRY PERIOD. The entry period for the contest will begin at 12 a.m. CDT on June 25, 2026, and end at 11:59 p.m. CDT on July 10, 2026.

3. HOW TO ENTER. To enter to win, fill out an entry form at www.Arkansas.com/GreatAmericanStateFair during the contest entry period. For additional entry, follow Arkansas Tourism on Instagram (www.instagram.com/Arkansas).

4. ELIGIBILITY. This contest is open to anyone 21 and older who resides in the United States (50 states plus the District of Columbia) and submits a valid entry during the entry period. Employees of ADPHT and their families are prohibited from winning this contest.

5. PRIZE WINNER SELECTION. The winner will be chosen at random from all valid entries. The winner will be contacted via phone and/or email by July 31, 2026. If a winner does not claim their prize after 48 hours, another winner will be randomly selected until the prize is awarded.
