

Arkansas Department of Parks, Heritage and Tourism (ADPHT) Contest Rules

Ride with USA Cycling National Team Athlete Trip Giveaway

- 1. THE CONTEST. Arkansas Tourism (a division of ADPHT) is celebrating the arrival of the USA Cycling National Team to the Big Sugar Classic in Bentonville, Arkansas, by giving away the chance of a lifetime. One lucky winner and a guest of their choosing will receive a two-night trip to the event and a one-hour ride with a USA Cycling National Team athlete, plus so much more!
- 2. THE ENTRY PERIOD. The entry period for the contest will begin at 12 a.m. CDT on Sept. 15, 2025, and ends at 11:59 p.m. CDT on Sept. 26, 2025.
- 3. HOW TO ENTER. To enter, visit www.Arkansas.com/USA-Cycling-Trip-Giveaway and submit an entry form during the contest entry period. Limit one entry per contest per participant.
- 4. ELIGIBILITY. This contest is open to anyone 21 and older who resides in the United States (50 states plus the District of Columbia) and submits a valid entry during the entry period. Only one (1) entry per user per contest will be considered for the prize drawing. Employees of ADPHT and their families are prohibited from winning this contest.
- 5. PRIZE WINNER SELECTION. The winner will be chosen at random from all valid entries. The winner will be announced on Oct. 1, 2025. If a winner does not claim their prize after 48 hours, another winner will be randomly selected until the prize is awarded.
- 6. PRIZES. A two-night trip for two to the Big Sugar Classic in Bentonville, Arkansas, that includes a one-hour ride with a USA Cycling National Team athlete, VIP access to the Community Dual Slalom Race, a Team USA Ride Bundle, and invites to the post-race party at The Hub.
