

Arkansas Fishing Giveaway

Official Contest Rules

1. **THE CONTEST.** Enter for a chance to win a fishing trip in The Natural State. Arkansas Tourism is giving away an all-expenses-paid fishing adventure for one lucky winner and a guest.
2. **THE ENTRY PERIOD.** The entry period for this contest will begin at 8:00 a.m. (CST) on June 1, 2023 and close at 11:59 p.m. (CST) on June 30, 2023.
3. **HOW TO ENTER.** To enter, go to [Arkansas.com/fishing](https://arkansas.com/fishing) and complete the entry form. Limit one entry per person.
4. **ELIGIBILITY.** This contest is open to anyone age 21 and older who resides in the contiguous U.S. (48 states plus the District of Columbia) and submits a valid entry during the entry period. Only one entry per user will be considered for the grand prize drawing. Eligibility is limited to users who are not currently employed by Arkansas Department of Parks, Heritage and Tourism and have residence in the contiguous U.S.
5. **PRIZE WINNER SELECTION.** Winner will be randomly chosen out of all entrants. Winner will be contacted via email and phone after a grand prize winner is randomly selected. Once contacted, the winner has seven (7) days to claim their prize. Prize can be claimed over the phone or by email. If a winner does not claim the prize after seven (7) days, another winner will be randomly selected, and so on until the grand prize is claimed. Estimated odds of winning are 1 in 15,000.
6. **PRIZES.** Grand prize winner will receive an Arkansas fishing getaway. The trip is available for up to two adults 21 and older for a four-day, three-night stay anywhere in Arkansas. Expenses covered are flights, rental car, lodging, food, and outfitter rental fees up to \$5,000. Winner will work with the planning team to coordinate dates of vacation, but the trip must occur prior to June 30, 2024. If the winner is

unable to claim the prize within certain parameters, another winner will be chosen, and so on until all prizes are claimed.
